# Former Lucasville prisoners in general population prisons

George Skatzes, #173-501, Chillicothe Correctional Institution, P. O. Box 5500, Chillicothe, OH 45601. Skatzes was a negotiator for the prisoners. He is now on death row.

Gregory Curry, #213-159, Ohio State Penitentiary, 878 Coitsville-Hubbard Road, Youngstown, OH 44505. Curry was convicted for his participation in the "death squad" on the first day of the uprising.

Leroy Elmore, #191-839, Richland Correctional Institution, P. O. Box 8107, Mansfield, OH 44905. Elmore was one of three Muslims who attempted to negotiate with the warden on the eve of the rebellion.

Roy Slider, #157-322, Toledo Correctional Institution, P. O. Box 80033, Toledo, OH 43608. Slider was in segregation at Lucasville before, during, and after the rebellion and again in recent years.

### Former Lucasville prisoners now in extended restrictive housing

These men are alleged leaders of the rebellion. They are sentenced to death. They have been held at the highest security level in the Ohio State Penitentiary since it opened in 1998. The address is: 878 Coitsville-Hubbard Road, Youngstown, OH 44505

They are not permitted face-to-face media interviews. To speak with one of them by phone, he must put the name and number on his phone list, and he must initiate the call.
